# Home again: reunification practice in England

Reunification is the most common way for children in England to leave care. However, the number of children who later return to care suggests that local authorities in England are facing challenges in delivering effective reunification practice.

The report, published by NSPCC Learning in collaboration with Action for Chjildren, identifies a number of key findings to inform future research and policy development. It also makes recommendations to raise the profile of this policy area and to support local authorities to develop their reunification practice approaches.

### **Return Home Interview Training**

There are more than 70,000 young people and children who go missing each year, with incidents estimated at 215,000 for these children and young people. Children and young people who go missing or runaway can be at risk, and return interviews are a way in which this – or any actual harm – can be uncovered and dealt with.

Our return home interview training supports independent people to focus on reducing the need for young people to go missing. This course explores how to equip participants with the knowledge and abilities to respond promptly to referrals and work alongside young people to understand the reasons they left, where they have been, and the level of harm they have experienced. Most importantly to work with local agencies and the child's family and carers about what needs to change to reduce this in future.

## The current course is suitable for those working in Children's Homes and Supported Accommodation.

This half-day course, delivered via zoom, costs £69+vat, reduced to £52+vat for members.

### Developing specialisms communities of interest

As the communities continue to grow, we wanted to remind current members that these meetings are contain essential information to support your statements of purpose, improve the care of the young people you support AND lighten to the load of the Registered Manager. The communities meet quarterly with 2-3 hours of CPD including updates on recent research, speakers, a surgery and sharing of great practice.
