## Disposable vapes banned to protect children's health

The government has announced plans for disposable vapes to be banned across the UK. To protect children's health, the government also plans to restrict vape flavours, introduce plain packaging and change how vapes are displayed in shops to make them less appealing to children. New fines will also be introduced in England and Wales to crackdown on underage sales.

Disposable vapes are said to be the key driver behind the alarming increase in youth vaping. The Children's Commissioner for England said, "children as young as 12
... told me that vaping was normalised among their peers - even on school premises". There is also a rise in unlawful high capacity vapes and using vapes for drug
misuse - look for the CE mark on the device as one indicator to check they're legal.

Our training course on smoking and vaping cessation provides staff with evidence based knowledge and skills to make a difference to young people and demonstrate you are putting their health outcomes front and centre. Managers and staff will have the opportunity to bring and reflect on their policies, organisational strategy and performance around smoking and vaping cessation.

## NSPCC Helpline- raising awareness

Alongside the Home Office, the NSPCC has launched a campaign to raise awareness of its Helpline and encourage adults to report if they have any concerns that a child may be at risk of or is being sexually abused, even if they're uncertain about what may be going on.

They have created two new films to support the campaign, one for the general public and another for professionals.

The NSPCC also runs a whistleblowing helplinefor those with child protection concerns within their organisation.

## Introduction to Harmful Sexual Behaviours Training

Young people in care have a greater need for protection, but may also have had experiences which create the conditions for them to pose a risk to others. This course examines the real dilemmas in working with young people, how to begin to identify risk, and keeps a strong focus on the rights to a healthy childhood for all the young people involved.

Our HSB training aims to:

- Improve professionals' practical knowledge of Harmful Sexual Behaviours (HSB) and increase confidence in dealing with HSB.
- Distinguish between developmentally typical sexual behaviour and sexual behaviour that is inappropriate, problematic, or abusive and know when and what action and intervention is required.
- Demonstrate an understanding of the prevalence of Harmful Sexual Behaviours (HSB)
- Highlight the increasing role of technology in HSB.
- Better understanding and response to the complexities of Technology-Assisted Child Sexual Abuse (TACSA)
- Show the impact professional, personal and unconscious biases have when responding to HSB.
- Recognise and identify the impact of HSB on all people around the child including families and practitioners.
- Develop confidence in responding to young people exhibiting HSB including how we accurately document and record incidents.
- By using the assessment tools available, create and understand a safety and intervention plan.

## Developing specialisms communities of interest

> As the communities continue to grow, we wanted to remind current members that these meetings are contain essential information to support your statements of purpose, improve the care of the young people you support AND lighten to the load of the Registered Manager. If you miss a meeting you can also retrieve the resources from the archive in the members' areas, but the best way to get the most out of your memberships is to ensure the dates are saved in your diaries and you attend on the day.

Leading residential care can be an isolating experience and in truth is a job best shared. We've been working with leaders across the sector to create communities that regularly meet in line to discuss the issues that matter to you young people. By identifying leads for key areas, such as online safety, managers share the load with senior team members, then by connecting your team with similar leads in other homes we become less insular in practice and all learn how to improve.

The communities meet quarterly with 2-3 hours of CPD including updates on recent research, speakers, a surgery and sharing of great practice.

As always we've found ways to keep the costs very low and the more you engage the less you pay - joining one
