### Challenges young people are facing around sexuality and gender identity

The briefing uses insight from Childline counselling sessions and NSPCC Helpline contacts from 2022/23 about sexuality and gender identity.

Some young people who are LGBTQ+ will have supportive experiences as they explore their sexuality and gender identity. However, some young people face pressures or challenges.

#### Key themes include:

- coming out to the family
- conversion practices
- pressures in school
- pressure to choose a label
- young people struggling with guilt and self-acceptance.

#### **New research**

On Safer Internet Day, the UK Safer Internet Centre (UKSIC) released <u>new research</u> that suggests young people are excited about the changes in technology, but also feel they need more conversations and support regarding staying safe online.

Other findings include:

- Nearly three-quarters (74%) of parents and carers, and just under half (45%) of children have worries about safety as developments with artificial intelligence (AI), virtual reality (VR) and new social media apps continue to accelerate.
- While 70% of young people say they're excited about the potential of generative AI (genAI) to improve their lives, over half (53%) of children who have used genAI have seen their peers use it negatively.

80% of children and young people think that young people should be listened to more about changes in technology, such as how it can remain safe.

#### Developing specialisms communities of interest

As the communities continue to grow, we wanted to remind current members that these meetings are contain essential information to support your statements of purpose, improve the care of the young people you support AND lighten to the load of the Registered Manager.
