## Ofsted: Opening homes for children with the most complex needs

Ofsted have written a blog and launched a new advice line to try to lend their support to work to reduce reliance on unregistered settings.

They highlight the need for a suitable property with the correct planning permission (highlighting a common error) and that reducing restriction is built into your approach by design with the environment organised, adaptable, with places to be "safely and restfully alone, and areas for social gatherings". There is growing concern at children being in sole placements with little opportunity to socialise and limited progress for some towards integrating with other young people. While sometimes necessary this is not good for young people and also means many settings are registered for more young people than are living there.

Having a "skilled and experienced manager" is obviously a 'must', but interestingly, "a committed Responsible Individual" gets a mention – frequent visits, essential management oversight, an ability to build trust with young people and reflection on how the staff team are working are key criteria.

We've been discussing a changed emphasis towards RIs in the dialogue membership sessions with some providers reporting that Ofsted are declining registrations for homes where external consultants hold this role: it's crucial RIs have sufficient capacity (Reg 26(7)(b)) to undertake the work and are "a director, manager, secretary or other officer of an organisation" (Reg 2).

Lots to think about and Ofsted plan to publish guidance on this area soon. Ofsted's advice line can answer specific questions for providers thinking about opening a new home on premises, staffing or children's needs, or wider issues.

## Children's social work workforce - reporting statistics for 2024

Good news here... statistics just released showing a rise in the number of social workers, a reduction in agency staff, a drop of almost 7% in social work vacancies, a reduction in caseloads and most importantly a reduction in social workers' turnover. This builds on positive progress last year.

All this leads to greater stability, better understanding of families, consistencies in relationships with families and professionals, and altogether better decisions for children.

Children's homes value our relationships with our social workers colleagues and it's good to see more stability in the system. It's crucial that we continue this trajectory as the needs of young people still outstrip services available and we need to keep working hard to ensure young people are getting the right support.

For today though it is good to report some improvements in the pressures on the social work teams.

# Survey for professionals on the definitions of various forms of child exploitation

This survey from <a href="NWG Network">NWG Network</a> is part of research on how language affects child trafficking, but is also in the context of criticism that the definition of exploitation may undermine actions to keep young people safe.

In particular, it seeks to explore UK child protection actors' understanding and use of child exploitation definitions and the impact this may have on children. The research is in response to the new government's commitment to a definition of the offence of child criminal exploitation and aims to develop policy recommendations and drive a better response to children affected by modern slavery.

The survey takes approximately 20minutes to complete using the link below.



## **Supervising time with Families training**

Family time is important for all of us. For some young people, especially those in care, time with families brings complications and in some cases this time needs to be supervised.
