Harmful Sexual Behaviour

As the debate continues regarding children's smartphone use, The Guardian has <u>commented on the findings</u> of analysis by the British Medical Journal. The <u>article by the</u>

BMJ argues that blanket bans on smartphone and social media use may be detrimental.

The Children's Commissioner has published a report following landmark research involving over 19,000 schools and colleges in England. The report outlines that while almost 99% of primary schools and 90% of secondary schools have policies in place limiting smartphone use in school, children's online safety continues to be on ongoing concern because of the amount of time children spend on their phones when not in school.

The Children's Commissioner goes on to argue that "If we want to protect children, we must broaden our focus beyond school gates and ensure they are safe online at all times."

Surge in child sexual abuse imagery

A report released by the Internet Watch Foundation (IWF) reveals that the EU remains a prime destination for criminals determined to share, sell and buy sexual images and videos of children.

The IWF is Europe's largest hotline for the detection, assessment and removal of child sexual abuse imagery online and it is one of only a handful of hotlines in the world with the legal powers to proactively search for this content.

The IWF says that data like this should 'act as clarion call' for Member States to urgently move forward with the much-delayed EU child sexual abuse regulation which lays down rules for preventing and combating child sexual abuse.
