Children's Homes Regulations

Regulation 40

The registered person must notify HMCI and each other relevant person without delay if -

- A child dies
- A child is suspected of being involved in or subject to CSE
- Police involvement the RP considers serious
- Allegation of abuse against the home or someone working there
- Child protection enquiry is instigated (or concludes)
- Any other incident the RP considers serious

14.11 Homes should also consider the frequency of incidents and judge whether their cumulative effect makes notification appropriate even if in isolation each event would not warrant this.



Children's Homes SCCIF Key Elements

"Inspectors must regularly review notifications and ... usually assess the management of a recent serious incident (where relevant). This is so that they can understand how the staff team responds to complex and difficult circumstances; whether the actions and responses of leaders, managers and staff are focused on promoting and safeguarding the welfare of children; and how the provider applied the learning from the incident"

Children's Homes SCCIF Key Elements


Notifications must take place "without delay". Inspectors will check:

• The registered person ensures that notifications of all significant events that relate to the welfare and protection of children living in the home are made to the appropriate authorities.

• The registered person takes the necessary action following the incident to ensure that the child's needs are met and that they are safe and protected.

• Leaders and managers regularly review and act on any known risks to children in the community, taking advice and guidance from local partners and agencies.

Ofsted comment from inspection – requires improvement



Top tips...

- **1. Review all regulation 40 notifications regularly** to identify patterns and trends over time
- 2. If unsure if an incident meets the criteria for notification seek advice from your inspector and note the incident. Dialogue members are welcome to seek initial safeguarding or regulatory advice from our helpline
- **3. Be curious in relation to changes in the behaviours of children** that may indicate they are at risk and you suspect safeguarding concerns are involved and ensure all staff are aware. Consider the need for 'cumulative' notifications
- **4. Create a clear plan to provide the regulator (and yourself!)** with reassurance the risks are well managed following a serious incident

Questions to consider...

- Are the team curious and alert to behaviours of a child that may indicate something is wrong?
- If you are unsure of the need to notify concerns over cumulative incidents have I contacted my Ofsted Inspector?
- Am I regularly reviewing the notifications, debriefs and information available to be fully aware of the risk to a child?
- Who reports serious incidents without delay when I'm not around?
