## Evaluation of Regional Care Cooperatives: phase 1

**Phase 1 of the RCCs has been completed. They highlight the progress pathfinders had made in starting to bring about a culture change - moving towards more proactive and collaborative commissioning to meet children's needs and fostering a willingness to share data and make a funding commitment.**

It's early stages at this point, really consolidating work that was already in place, but the two pilot RCCs have plans to move forward and, after heaving criticism in the National Audit Office report, the DfE are moving at pace to create opportunities for other regions to follow.

## Debriefs following restraint

This research examined debriefs after restraint in secure settings in Scotland, building towards an aim of restraint reduction. It found different interpretations of what the debrief was for, that debriefs tend to be a series of discussions rather than a single meeting, the real value of caring about care staff and that debriefs contribute towards but are not the sole factor in restraint reduction.

It would be good for providers to explore the meaning of debriefs across their team, the impact and consistency of delivery and what steps they can take to improve this important process.

## Managing Allegations training

**While guidance requires regulated settings to follow safeguarding procedures when a child may have been**

**harmed by a member of staff or volunteer, our research found a quarter did not offer managing allegations training and only a third had received personnel training.**

This course will ensure managers have the skills to prioritise the safety of children and young people, work within interagency procedures and guidance and properly support their staff through proportionate decision-making and a caring approach.

### **The trainer:**

**Brian Smith** is a qualified Social Worker, and has previously held the position of a Responsible Individual. Brian has experience of over 37 years in social care to work with service providers to improve services to children. What drives Brian is a continued belief that we must do better in achieving positive outcomes for children in care and use the learning from all opportunities to improve the quality of life for these children.

## Use of photographs in Regulation 45 reports for children's homes

**Regulation 45 of The Children's Homes (England) Regulations 2015 specifies that the registered person must provide a written report of the quality of care review.**

When sending the report to Ofsted, they've asked providers not to include photographs of children, or anyone else that might be able to be identified, in these reports due to DP concerns.
